How do I access ETRS?

ETRS can be found [here](#). Some users have experienced problems when filing with Internet Explorer, so we recommend that filers use Chrome or Firefox.

Users can log in to ETRS, as well as obtain Information on how to access ETRS at <https://www.fcc.gov/general/eas-test-reporting-system>. Users can log in to ETRS using their Commission Registration System (CORES) account. Users who do not have a CORES account may register for one at <https://apps.fcc.gov/cores/userLogin.do>. Once on the ETRS webpage, there is an instructional video (see tab at the top of the page) that provides guidance on how to log in (see screenshot of the web page below).

How do I complete an ETRS form if I receive a notification/error message that the window for the test cycle is closed?

There are a few reasons you may be experiencing this issue. It may be because you are attempting to edit an ETRS form from a previous year. We require you to file a new Form One for each year by clicking on the appropriate option from the menu: Submit Form One. Once you enter an FCC Registration Number (FRN), your EAS Participant Type, and Facility ID (or Physical System ID (PSID) for cable operators) on that new form, it will populate with the last available year's data. After making any necessary updates, you can submit the form.

Registration

How to I register an ETRS account?

To access ETRS, you need to register an FCC Username in our Commission Registration System (CORES) and associate your EAS Participant’s FCC Registration Numbers (FRNs) to that Username. Please allow 24-48 hours for your FRNs to be associated with your Username. Filers that have already created a Username for use with another FCC system can use that same Username to access ETRS. You can register a Username at <https://apps2.fcc.gov/fccUserReg/pages/createAccount.htm>.

Can I use the ETRS-specific account that I created in 2016?

No. You will need to register an FCC Username in CORES.

Who needs to register and file in ETRS?

All EAS Participants are required to register an FCC Username and file Forms One, Two, and Three in ETRS. EAS Participants are radio and television broadcasters, cable systems, satellite radio and television providers, and wireline video providers.

I want to file for multiple stations. Should I file for them using the same FCC Username?

Yes. You can file for multiple FCC Registration Numbers (FRNs) using the same Username. To do so, you will need to associate all FRNs to your FCC Username in CORES. Please allow 24-48 hours for your FRNs to be associated with your Username. For further information, please review the ETRS Registration Public Notice at <https://docs.fcc.gov/public/attachments/DA-21-680A1.pdf>.

Can I register multiple accounts for the same EAS Participant?

Yes. Each user should register their own FCC Username. That Username will be able to file on behalf of any FCC Registration Number (FRN) that is associated to it. A single FRN can be associated with many FCC Usernames. Please allow 24-48 hours for your FRNs to be associated with your Username.

When I associate my EAS Participant's FCC Registration Number (FRN) to an FCC Username, will that Username be limited to filing in ETRS?

No. Usernames that have an associated FRN can file on behalf of that FRN in all FCC applications and edit all filings made on behalf of that FRN in ETRS. Please keep this mind when deciding which individuals within your organization should have FRNs associated with their Usernames.

I need an FCC Registration Number (FRN) to associate with my FCC Username for ETRS. How do I get one?

Every EAS Participant should already have an FRN. Please check with others in your organization to obtain your FRN and Password. If you need additional assistance, please contact FCC Licensing Support at 1-877-480-3201 (Mon.-Fri. 8 a.m.-6 p.m. ET) or via the web at <https://www.fcc.gov/wireless/available-support-services>. Who Must File ETRS Forms?

Are low power FM stations (LPFM) and small student radio stations (Class D) required to register and file in ETRS?

LPFM stations and Class D non-commercial educational FM stations are required to register and file in ETRS.

Are LPFM televisions stations that operate as television broadcast translator stations required to register and file in ETRS?

Analog and digital low power television (LPTV) stations that operate as television broadcast translator stations are **NOT** required to register and file in ETRS.

Are FM broadcast booster stations or translator stations that entirely rebroadcast the programming of other local FM broadcast stations required to register and file in ETRS?

FM broadcast booster stations and FM translator stations which entirely rebroadcast the programming of other local FM broadcast stations are **NOT** required to register and file in ETRS.

Are satellite stations or repeaters of a hub station required to register and file in ETRS?

Analog and digital broadcast stations that operate as satellites or repeaters of a hub station (or common studio or control point if there is no hub station) and rebroadcast 100 percent of the programming of the hub station (or common studio or control point) are **NOT** required to register and file in ETRS. However, the hub station (or common studio or control point) is required to register and file in ETRS.

I have a broadcast station with multiple HD stations (HD2, HD3, etc.). Do I need to file separately for each HD?

Each EAS Participant should file a separate copy of Form One for each of its EAS decoders, EAS encoders, and units combining such decoder and encoder functions. For example, if you are filing for a broadcaster (or cable headend) that uses two units combining decoder and encoder functions, you should file two copies of Form One – one for each unit.

Do EAS Participants need to resubmit Form One Yearly?

Yes, all EAS Participants were required to submit a new Form One for their EAS equipment starting in 2017. Form One data collected in past years will be used to pre-populate next year’s Form Ones. Please confirm the accuracy of your pre-populated Form One before submission.

I need to correct an error. How do I update forms that I have previously filed?

You can update previously filed forms by visiting the record for that facility in ETRS. You can access that record by clicking on the My Filings menu option. All corrections must be submitted within thirty (30) days of the initial deadline.

Filing Form One

How do I pre-populate Form One?

Broadcasters can pre-populate Form One by completing the FRN, EAS Participant Type, and Facility ID fields. Cable systems can pre-populate Form One by completing the FRN, EAS Participant Type, and PSID fields.

What is my Geographic Zone of Service?

Your Geographic Zones of Service are the geographic areas that your facility serves. To find your Geographic Zones of Service, review your state’s EAS plan. Each state EAS plan organizes the state into several operational areas. Each operational area in which the facility provides service should be submitted as a Geographic Zone of Service.

My Geographic Zone of Service/operational area does not appear to be in the FCC’s database.

If the operational area is not already in our database, you can add it to our database by clicking on the “Click here to add new geographic zones to the picker” link, which will let you type it in. Please enter it exactly as it appears in your state’s EAS plan.

Should I submit the latitude/longitude of my studio or my antenna?

You should submit that latitude/longitude of your broadcasting antenna.

I’ve typed in latitude/longitude and the map is showing an incorrect location.

Please ensure that your latitude/longitude is in NAD83 and decimal format.

How do I convert my latitude/longitude to NAD83 and/or decimal format?

The Commission has tools on its website that can assist you. Please visit <https://www.fcc.gov/media/radio/dms-decimal>.

How do I find my EAS designation?

Your station's EAS designation should be indicated in your state's EAS plan. Most EAS Participants will be Participating Nationals.

Where can I find my monitoring assignments?

Your EAS monitoring assignment can be found in your state’s EAS plan. Typing the monitoring assignment’s call sign into the Form One monitoring assignment fields will help you find the appropriate entry in our database. In addition, please ensure that your EAS equipment is monitoring these EAS sources.

My monitoring assignments do not appear to be in the FCC’s database.

Type the first three characters of the monitoring assignment’s call sign into the Form One monitoring assignment fields. If the correct call sign does not appear, click on the text under the Other Monitored Sources field that states “Is your Monitored Source missing? Click here to add a new Monitored Source.” Please enter the monitoring assignments exactly as it appears in your state’s EAS plan.

What is a waiver? Do I need a waiver?

Some EAS Participants may find that they have difficulty monitoring one or more of the EAS sources assigned by their state EAS plan. If those EAS Participants plan to monitor different EAS sources than those assigned in their state EAS plan, they must seek a waiver of the Commission’s Part 11 rules regarding EAS Participants’ monitoring obligations. EAS Participants that monitor the EAS sources

assigned by their state EAS plan do not need a waiver and should choose “no” to answer the Form One question related to waivers. In the event you need to seek a waiver in connection with your monitoring obligations, please allow sufficient time for your waiver request to be considered by Commission staff prior to this year’s nationwide test and plan accordingly.

How do I find out the make and model of my EAS equipment?

To determine if your EAS equipment is interfacing with FEMA’s IPAWS, contact your EAS equipment vendor.

I returned to an incomplete form after several hours, and I had to start over.

Please save your form data periodically by clicking the Save Draft button that is located at the bottom of each form. The current session time-out is approximately 30 minutes. If you return to complete your data, please return to the draft form rather than starting a new filing.

How do I add a call sign? My monitored source is not listed as an option in the ETRS dropdown menu.

Scroll down the form (just above Transmitter Location) and click on the box immediately below the Other Monitored sources field. Then manually add your call sign to the database.

Determine whether any additional designations apply to your EAS Participant. You can add designations after the first by clicking on the field again.

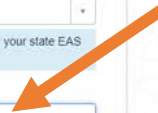

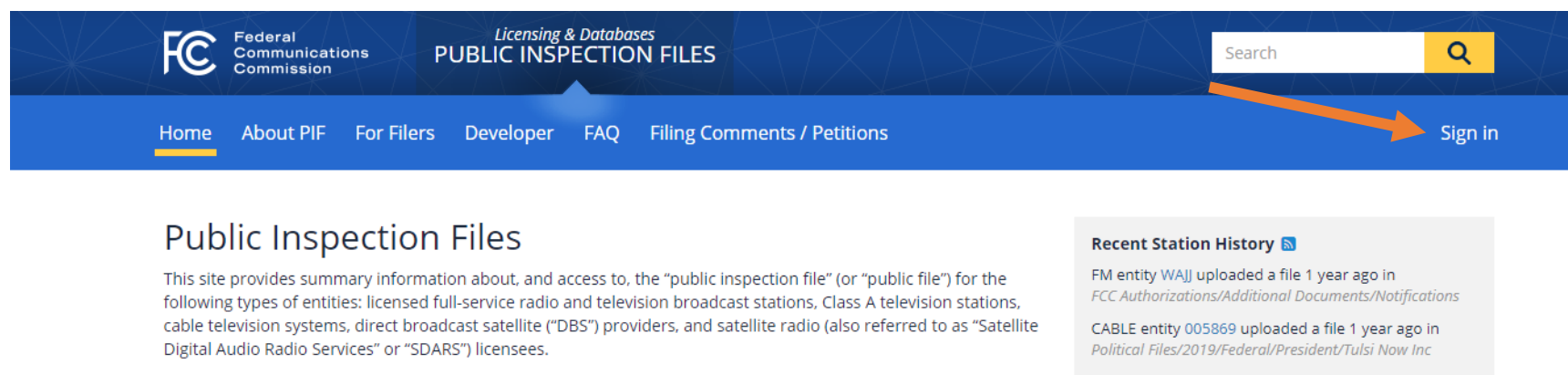

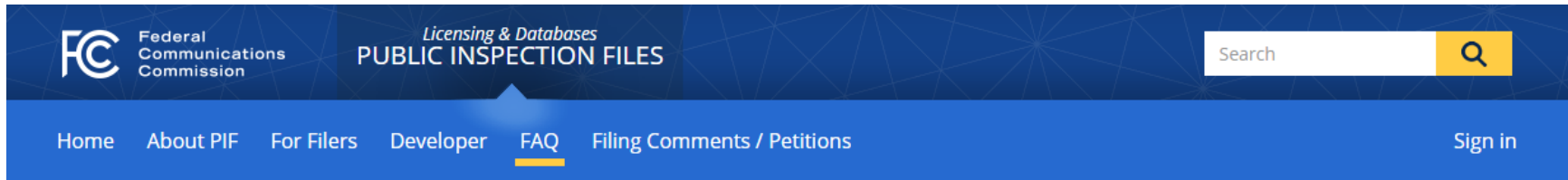
EAS Participants that pre-populate Form One using a Facility ID number or a Physical System ID (PSID) number are urged to review their pre-populated data to ensure accuracy. Outdated or inaccurate data fields that cannot be edited in ETRS are populated from the EAS Participant’s filings in the Commission’s Online Public Inspection File (OPIF). Accordingly, EAS Participants must ensure that their OPIF information is correct for it to appear accurately in ETRS. EAS Participants are urged to review Form One as soon as possible to allow sufficient time for possible OPIF corrections. Once information is corrected in OPIF, it will be updated in ETRS within 24 hours. [This](#) is the OPIF sign in page. Please find a more detailed answer below.

Step One: Update information in the database that feeds into ETRS.

ETRS is populated from the EAS Participant’s filings in the Commission’s Online Public Inspection File (OPIF), which is, in turn, updated from the Consolidated Database System (CDBS). You must first correct and update that CDBS information in the OPIF for it to accurately appear in ETRS. To do that, go to <https://publicfiles.fcc.gov> to log in to the OPIF. Use the Sign In button in the upper right-hand corner.



How do I edit the Day of Test Contact (DoTC) fields?


If you cannot edit the day-of-test contact fields directly, this is because you have indicated that the filer and the DoTC are the same. You can edit that field by completing all the Filer Contact Information fields or indicating “No” in the dropdown menu that the person designated in the Filer Contact Information fields is *not* the EAS Participant’s day of test contact.

Batch filing

How do I submit a batch filing?

Click on the "Submit Batch Filing" menu option. Download and complete the spreadsheet template. After you have completed the template, you can choose a test cycle on the batch filing page, upload your file, and submit it. You will receive an e-mail after your batch filing has processed. If corrections to your batch filing are needed, the e-mail will provide you with a link to a page that explains the corrections that you need to make before re-uploading the template. Filers should ensure that all fields are complete before uploading the batch filing.

I received an error message when attempting to upload my spreadsheet.

Spreadsheet templates must be saved in .xlsx format before being uploaded to ETRS. Instructions for saving in the correct format can be found in the User Documentation available in ETRS. We also strongly recommend that spreadsheets be edited and saved in Excel or errors may occur.

Can I file Form One using the same batch filing spreadsheet that I used last year?

When batch filing in ETRS, you can file by filling out and submitting the blank batch filing template spreadsheet that is provided on the Batch Filing page of ETRS. Alternatively, you can file by updating and submitting a batch filing spreadsheet that you filed in a prior year. To ensure that an updated spreadsheet is processed accurately, please take the following steps:

- Review column B of your spreadsheet to ensure that it correctly reflects the Form that you intend to file (e.g. Form One);
- Delete all Filing Numbers in column C of your spreadsheet, as these filing numbers change every year; and
- Delete any responses in columns AM through BM and any notes in Column CK of your spreadsheet that report test results from prior years.

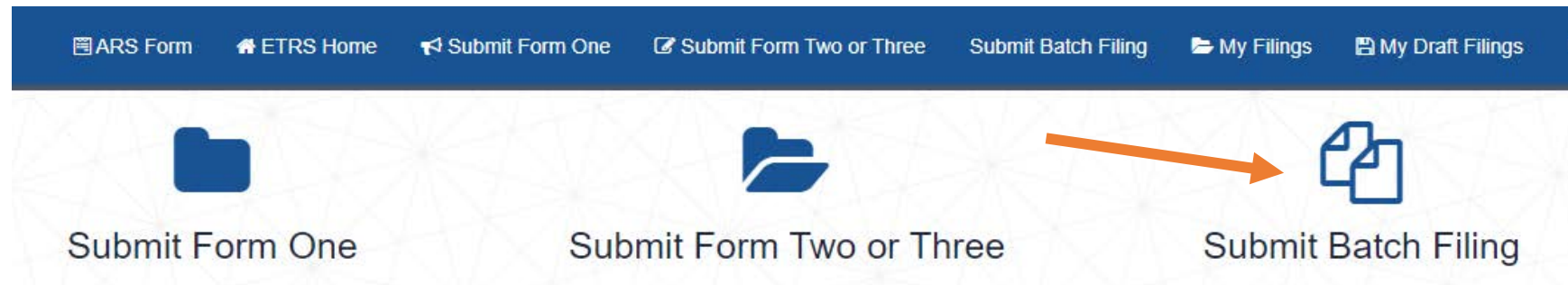


Step One: Click on "Submit Batch Filing" menu option

From the main ETRS page, find the Submit Batch Filing thumbnail tile. This will bring up your submitted batch filings. On the filing in question, it should say "Correction to Filing Needed" under "Status."



Step two: Click on Section Labeled “Correction to Filing Needed”

The section “Correction to Filing Needed” will bring you to a list of the filings that require correction.



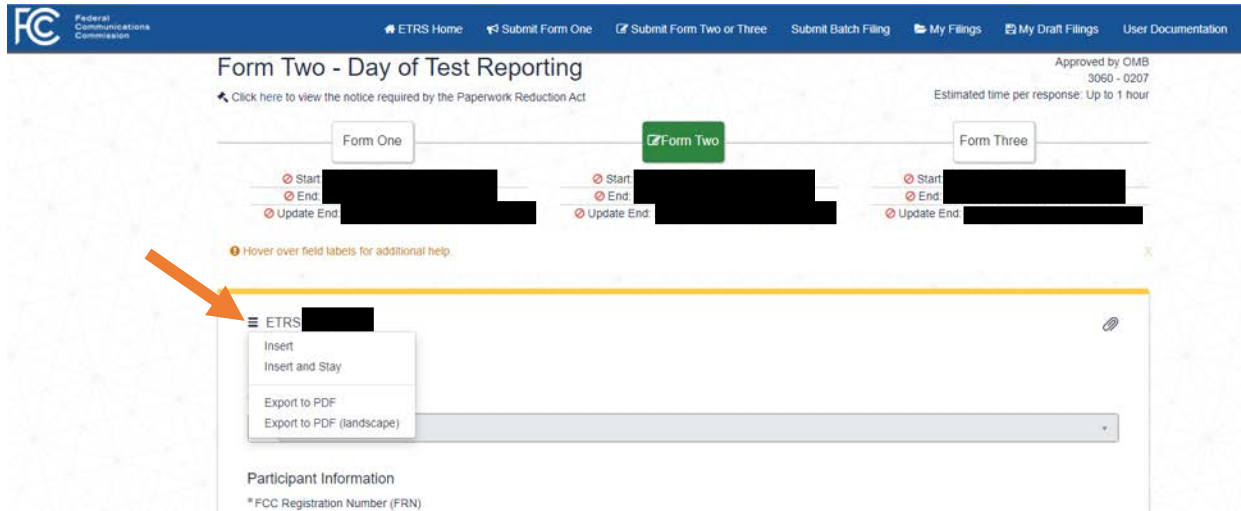

For individual filings, only PDF or PDF (landscape) is an option under the menu.

* CSV stands for comma-separated value. This type of download allows data to be saved in a tabular format. CSV files can be used with many spreadsheet programs, such as Microsoft Excel or Google Spreadsheets.

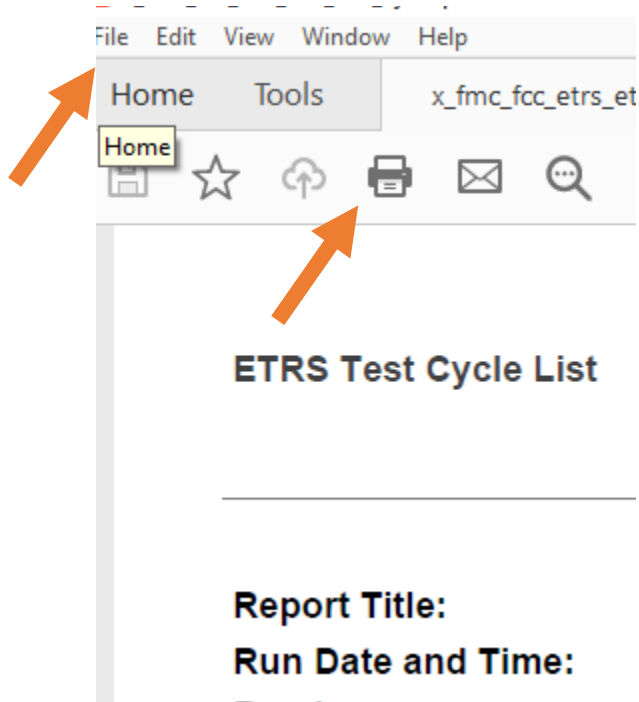


You may export the document as a PDF, Excel, or CSV file and print the group.
