### Explanation of Effort and Availability of Commercial Equipment

\*Provide an explanation of efforts undertaken, and challenges encountered, in permanently removing, replacing, and disposing of covered communications equipment or service.

Copper Valley Wireless (CVW) continues progressing forward with its efforts to replace its existing ZTE CDMA network. CVW has completed the removal of the covered ZTE equipment from all of its sites, along with the CDMA Core Network equipment from the Glennallen CO. Partial replacement installation efforts have occurred at CVW's Heney Ridge and Tsaina Mountain sites, the covered ZTE equipment has been fully decommissioned from these sites. All removed covered equipment was securely stored it in a connex shipping container at CVW's secure facility, and after final review of the decommissioning logs and revising its quotations, CVW shipped the covered ZTE equipment to the ITAR certified recycler. CVW has received the final Certificate of Destruction and accompanying documentation from the ITAR certified recycler confirming their covered ZTE equipment has been destroyed per Program guidance. The antenna and line installation activities at its Lake Louise site were completed in early January of 2023, after having been delayed since early July of 2022, due to an osprey nest (Federally protected). CVW's 2022 build efforts were slowed due to CVW's contractor, New Horizons Telecom (NHTI), only being able to assign one tower crew to the CVW project for its 2023 efforts. CVW's 2022 efforts on its replacement and removal efforts were also further slowed by unforeseen weather events, the northern portion of CVW's footprint had an exceedingly wet year, including earlier than typical snow accumulation which further limited the available windows for helicopter access to some of its sites. CVW's Divide site experienced installation and equipment removal delays due to coordination of the required State employee supervision. Helicopter access, in addition to available flight windows, also impeded CVW's activities in its 2022 construction season. The Naked Island structural analyses resulted in unforeseen tower reinforcements and CVW experienced 8-10-week leadtimes to receive the structural components, delaying its originally scheduled efforts. The spring and early summer of 2023 had presented CVW and NHTI with several weather delays impacting site accessibility and maintenance window cutover efforts, along with unworkable ground conditions that have prohibited NHTI from adhering to the previously submitted schedule. The weather continued impacting the fall of 2023 construction activities, causing delays with site accessibility and maintenance window cutover efforts. Permitting delays, at the Eyak Lake and Heney Ridge sites have also impacted CVW's construction timeline. For Heney Ridge, the foundation designs have been completed, and the tower steel has been received. Heney Ridge has required collaboration between, CVW, the State of Alaska, and NHTI. Working through tower crew scheduling delays and weather windows favorable for helicopter access, CVW, the State of Alaska, and NHTI conducted an onsite meeting to discuss the process of transitioning the State's deployment to a temporary installation while the old tower and foundation are dismantled, and the new tower and foundation are constructed. NHTI is scheduled to commence Heney Ridge tower dismantlement the first week of October barring weather delays. The first significant snowfall of the winter just occurred at the Tsaina Mountain site, which may impede progress at the Tsaina Mountain site. However, NHTI will be monitoring snowfall and tower crew availability to find an appropriate weather window to accomplish the required tower modifications at the Tsaina Mountain site. If the snowfall persists at the Tsaina Mountain site, it will be unlikely that CVW is able to complete their SCRP related activities at the site within their existing RRD term. While awaiting full funding for the SCRP Program, CVW diligently continues its efforts, while financially straining to internally fund these efforts of the Supply Chain Proceeding.

In December of 2020 and September of 2021, CVW ordered its transmission line cabling and eNode B electronics but has also encountered shipment delays on both its transmission line cabling, as well as portions of its eNode B electronics. Fortunately, CVW has been able to finalize its equipment and material orders, however, the lead-times have been exponentially longer than originally quoted and projected. CVW has continued to experience extended lead-times for the transmission line cabling for its 2023 site builds.

CVW estimates it is 97% complete in completing its Supply Chain Proceeding efforts and is uploading a revised project timeline into the portal to more accurately capture the progress it has made on its Supply Chain Proceeding activities and revised equipment and material lead-times to accompany its October 2024, 90-Day Status Update Filing.
