# INFORMAL WORKING GROUP 1 OF THE 2027 WORLD RADIOCOMMUNICATION CONFERENCE ADVISORY COMMITTEE

July 17, 2024

Mr. Kolb informed the IWG-1 that the International Civil Aviation Organization (ICAO), 19<sup>th</sup> Frequency Spectrum Management Panel (FSMP) is currently ongoing and scheduled to conclude on July 26th, 2024.

#### 7. IWG-1 Agenda Items (Document: IWG-1\_007 - NTIA Letter to FCC\_WRC-27 Preliminary Views\_1.2 1.9 1.13 1.15 and 1.16)

Mr. Kolb indicated no contributions were received regarding WRC-27 Als 1.8, 1.9, 2, 4, 8 and 10. Mr. Kolb provided the meeting with document IWG-1\_007 and requested if the meeting could consider adoption of the NTIA PV for Al 1.9 contained within the document. Mr. Damon Ladson volunteered to develop text for an IWG-1 proposal on Al 1.9 and to coordinate with Mr. Eric Lee for some clarifications of the NTIA PV to assist with the proposed text.

# 8. IWG-1 Agenda Item Proposals Coordinators

Mr. Kolb sought coordinators or leads to draft material for Als 1.8 and 1.9. No individuals were appointed as coordinators at this meeting.

# 9. Future Meetings

Mr. Kolb informed the IWG-1 of the next scheduled IWG and WAC meetings. The next IWG-1 meetings are scheduled for July 24, 2024 and July 31, 2024 starting at 11:00
