Meeting Summary:

1. Opening Remarks and Introductions

IWG-2 Chair Daudeline Meme provided opening remarks; confirmed FCC participation; and requested attendees to update their names on Zoom to include affiliation. She stressed the need to work collaboratively to reach consensus on recommendations to the FCC for the agenda items assigned to IWG-2.

2. Approval of Agenda and Minutes

The agenda was updated to reflect comments received from Lockheed Martin and NCTA/Charter. The agenda in Document **IWG-2/006 (07.17.24)** was approved. The minutes of the previous meeting in Document **IWG-2/005 (07.17.24)** was approved. Mr. Arefi offered to take the minutes.

3. Updates

No updates were received from the FCC. Ms. Sanders (NTIA) stated there has been no activity on Agenda Items 1.7 and 1.10 in the RCS. RCS is reviewing the IWG-2 input documents.

4. Initial Discussions towards Development of IWG-2 Preliminary Views

a. WRC-27 Agenda Item 1.7: Mr. Mullinix (CTIA) introduced Document **IWG-2/007 (07.17.24)** and discussed the edits received from NCTA/Charter and Lockheed Martin. Mr. Kotler (Lockheed Martin) and Mr. Thakker (NCTA) discussed submission of edits. Mr. Kolb (Boeing), Mr. Motamed (AT&T) and Mr. John (Fleet Space) provided comments. There will be an offline on Tuesday, July 23, 2024 to discuss the PV. Chair requested the output of the offline to be sent by COB Tuesday for consideration at next the IWG-2 meeting.

b. WRC-27 Agenda Item 1.10: Mr. Motamed introduced Document **IWG-2/008 (07.17.24)** and stated that no comments were received. Chair indicated that if no additional comments are submitted, the PV can be considered for approval at the next IWG-2 meeting.
