### Explanation of Effort and Availability of Commercial Equipment

\*Provide an explanation of efforts undertaken, and challenges encountered, in permanently removing, replacing, and disposing of covered communications equipment or service.

LigTel Communications, Inc. (LigTel) continues progressing forward with its Fiber to the Premises (FTTP) network upgrade to replace its existing Huawei Fixed Wireless Access (FWA) network. LigTel has completed the FTTP Outside Plant (OSP) construction activities in its exchanges of LaGrange (Exchange 1). Rome City (Exchange 2), Skinner Lake (Exchange 5), Sylvan Lake (Exchange 3), Albion (Exchange 4), and LaOtto (Exchange 6), as well as commenced the construction efforts at Cromwell (Exchange 7). As subscribers are cutover to the FTTP network, LigTel is decommissioning the FWA customer premises equipment (CPE). Ligtel has completed the turn down and decommissioning of its radio access network and its tower decommissioning efforts have been completed at its LaGrange, Shipshewana, Topeka, South Milford, Kendallville, Big Lake, Albion, Avilla, and Cromwell sites. Tower decommissioning activities were delayed by an osprey nest at the final two sites of Wolcottville and Merriam. The groundwork to complete the decommissioning activities at each of the sites was completed in December of 2023. The decommissioning of the core network was completed in early January of 2024. With the completion of the decommissioning and removal efforts of all covered Huawei equipment from their network, LigTel is transitioning into the disposal phase of the SCRP Program. LigTel has completed cataloging and final verification of their covered Huawei equipment. Ligtel's covered equipment was picked up from their secured facility and was transported to the certified ITAR recycler. LigTel's selected ITAR recycler is currently working through its receiving, inventorying, and processing procedures. LigTel's efforts on its FTTP network construction in two of its exchanges were slowed by unforeseen road construction activities. In the LaGrange exchange its efforts were slowed by local street construction activities and in the Sylvan Lake exchange its efforts were slowed by the State of Indiana road construction activities. Early on in the process, LigTel ordered its fiber optic cabling and FTTP electronics but has encountered shipment delays on both its fiber optic cabling, as well as portions of its FTTP electronics. While awaiting full funding for the SCRP Program, LigTel diligently continues its efforts, while financially straining to internally fund these efforts, to prolong enacting the one-year completion deadline obligation of the Supply Chain Proceeding.

Early on in the process, LigTel ordered its fiber optic cabling and FTTP electronics but has encountered shipment delays on both its fiber optic cabling, as well as portions of its FTTP electronics. Fortunately, LigTel has been able to finalize its equipment and material orders, however, the lead-times have been exponentially longer than originally quoted and projected.

While awaiting full funding for the SCRP Program, LigTel diligently continues its efforts to transition to its FTTP network upgrade and is in process of complying with all requirements of the Supply Chain Proceeding. LigTel estimates it is 95% complete in completing its Supply Chain Proceeding replacement efforts, is 80% complete in its Supply Chain Proceeding Recycling efforts, and is uploading a revised project timeline into the portal to more accurately capture the progress it has made on its Supply Chain Proceeding activities, including its FTTP construction activities, and revised equipment and material lead-times.
