

NANP FUND BUDGET AND CONTRIBUTION FACTOR FOR OCTOBER 2024 TO SEPTEMBER 2025

To: North American Numbering Council

Budget and Contribution Factor

The budget has been prepared to determine the funding requirements and the contribution factor for the upcoming funding period. The budget covers a 12-month period running from October 2024 to September 2025. We have determined that the total projected cost before the provision for contingency allowance and offset of the current year projected surplus is \$7,460,052. The Numbering Administration Oversight Working Group (NAOWG) determined that a \$1,000,000 contingency allowance be allowed for in the budget resulting in a total cost of \$8,460,052. The projected surplus of \$1,693,276 as per the April 2024 NANP report to the NAOWG will be used to offset the total funding requirement. This offset results in a total cost to be borne by US carriers of \$6,766,776. Rationale for this level of expenditure is included under the heading 'Basis for Projected Disbursements'.

Based on the funding requirement discussed above and the projected revenue base of \$75.5 billion, the resulting contribution factor is 0.0000896.

Revenue Contribution Base

The revenue base used for billing purposes and the determination of the contribution factor continues to decline. There was a 4% decrease in the revenue base over last year. The preliminary revenue figure of \$75.5 billion used for determining the contribution factor is drawn from the 2024 Form 499A reports received by USAC up to May 15, 2024. For those carriers who have not yet submitted their 2024 Form 499A, the revenue reported on the 2023 Form 499A is used.

Basis for Projected Disbursements

The functions of the North American Numbering Plan Administrator (NANPA) and Pooling Administrator (PA) were combined into one contract that was awarded to SomosGov. The contract is a 5-year contract that covers the period from December 1, 2020, to November 30, 2025. The cost provided in the budget is as per the contract. The International Participants (non-U.S. member countries) will contribute \$179,684 towards numbering administration costs. Since the NANPA and PA are no longer separate contracts, SomosGov determined that 43% of the total cost relates to NANPA functions. The International Participants' contribution towards the NANPA costs is based on a historical basis whereby 69% of the total numbering administration cost relates to North American Numbering Plan (NANP) administration and 31% relates to U.S. central office (CO) code administration. The International Participants contribute only towards NANP administration, as they perform their own CO code administration. Each International Participant's contribution is based on its proportionate percentage of the total average estimated population of all member countries, for the years 2024 and 2025. Their contribution is further discounted for NANPA work done by each respective country (Canada – 25%, other non-U.S. countries – 66%).

The cost for the carrier audits has been provided for as directed by the FCC and as required under 47 C.F.R. §52.15(k) and FCC Order FCC 00-42.

The Billing & Collection Agent contract expires April 30, 2024. The cost provided for in the budget is based on the contract extension as amended in April 2023. The RFQ for this contract was posted April 12, 2024.

The cost for the Data Collection Agent is established based on an estimate provided by USAC. If additional work is required due to new FCC initiatives, the cost could be higher.

The cost for the annual operations audit for the Fund has been provided for at an estimate based on the prior years' billing history by Ernst & Young LLP.

Bank fees are an estimate based on prior years.

Bad debts are an estimate of uncollectible accounts. This amount is based on prior years' history.

An estimate of the interest income earned from the bank is based on prior years' history and current interest rates and cash balances.

Carriers are charged a \$100 fee when they do not file their Form 499A by the due date of April 30th. This fee is over and above the amount they are required to pay NANP to cover the costs of numbering administration. An estimate has been provided based on results from previous funding years.

The anticipated current year surplus based on the April 30, 2024 report to the NAOWG is estimated to be \$1,693,276.

The contingency allowance is to provide for unknown additional costs at the time of the preparation of the budget. The following list includes examples of costs that would be covered by the contingency fund.

- Change orders.
- Costs related to a change in scope of work of the contractors as mandated by the FCC.
- Additional costs due to the Billing & Collection Agent contract being awarded at an amount greater than provided for in the budget.
- Any other costs not provided for in the budget.
