FCC OIG Audits, Inspections, and Evaluations Status of Open Recommendations

EXECUTIVE SUMMARY

As the Federal Communications Commission (FCC or Commission) Office of Inspector General (OIG) conducts audits, inspections, and evaluations, we issue recommendations to the Commission to address identified risks and issues. FCC OIG staff from the Office of Audits monitor progress towards corrective actions and once FCC provides adequate support and documentation that it has addressed and implemented each recommendation, FCC OIG will close the recommendation. There are currently 37 open recommendations from FCC OIG's audits, inspections, and evaluations.

The purpose of this new product is to provide the current status of these open FCC OIG recommendations, and to identify nine recommendations that FCC OIG has assessed as priorities. We hope this resource will help highlight the Commission's progress and identify opportunities for continued improvements to address these open recommendations. The first 27 open recommendations listed arise out of our Federal Information Security Modernization Act (FISMA) evaluations and relate to Information Technology. These recommendations are considered sensitive and contain non-public information. Therefore, this public version of the report includes the domain for each FISMA recommendation and modified descriptions of the status to avoid the release of sensitive and non-public information.

The Commission has made significant progress over the past six months to resolve several open FCC OIG recommendations from prior audits, evaluations, and inspections. At the conclusion of each semiannual period, we issue a memorandum to FCC summarizing the recommendations that were closed during the preceding six months. For example, on October 9, 2024, we issued a memorandum listing 24 recommendations that were closed for the semiannual period of April 1, 2024, through September 30, 2024. We plan to issue a separate memorandum on the recommendations closed for the semiannual period ending March 31, 2025.

We appreciate FCC's cooperation and attention to these issues and its significant efforts to resolve them. We look forward continuing to coordinate with the Commission as it works to address the remaining open recommendations.
