Explanation of Effort and Availability of Commercial Equipment

Velocity Communications, Inc. (Velocity) remains committed to progressing with the FCC's Supply Chain Reimbursement Program (SCRP), despite the current challenge of limited funding. From the start, we have actively engaged with potential vendors, negotiated terms, and carefully assessed our financial capacity to ensure we are prepared to meet the program's requirements. These efforts highlight our ongoing dedication to moving forward, even within the constraints of the available resources.

Our primary concern is the feasibility of completing the full network buildout with only 40% of the necessary funding allocated. While we have made significant progress in identifying vendors and securing agreements, proceeding without full funding risks leaving the network upgrade incomplete, potentially compromising both program compliance and the reliability of our services. The urgency of this situation is clear, and we are actively seeking a partner or solution to bridge the funding gap and keep the project on track.

Despite these challenges, we have made tangible progress, including the completion of key tasks such as decommissioning Huawei equipment. Although our reimbursement submissions do not yet fully reflect all of our accomplishments, we continue to finalize invoices and destruction receipts for these milestones. Our phased approach to the project demonstrates our strategic planning and commitment to advancing the work while carefully managing financial risks.

However, the partial funding status remains a significant barrier, weakening our negotiating power with vendors and leading to potentially higher costs. We remain focused on finding ways to move forward responsibly while awaiting further clarity on additional funding.
