A RENEWAL OF THE COMPUTER MATCHING AGREEMENT BETWEEN THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY AND THE FEDERAL COMMUNICATIONS COMMISSION AND

THE UNITED STATES DEPARTMENT OF EDUCATION

Under the applicable provisions of the Privacy Act of 1974, as amended (5 U.S.C. § 552a), a computer matching agreement (CMA) will remain in effect for a period not to exceed 18 months. See 5 U.S.C. § 552a(o)(2)(C). Within 3 months prior to the expiration of such CMA, however, the Data Integrity Board (DIB) of each party to the CMA may, without additional review, renew the computer matching agreement for a current, ongoing matching program for a period not to exceed 12 additional months if:

- 1. Such matching program will be conducted without any change; and
- 2. Each party to the CMA certifies to the DIB in writing that the program has been conducted in compliance with the CMA.

5 U.S.C. § 552a(o)(2)(D).

A copy of the CMA to be renewed is attached hereto.

The following match meets the conditions for renewal upon signature of the officials authorized in sections VII through IX of this renewal of the CMA:

I PARTIES TO THE MATCH:

Source Agency: U.S. Department of Education (ED)

Recipient Agency: Universal Service Administrative Company (USAC) and

The Federal Communications Commission (FCC)

■ PURPOSE OF THE AGREEMENT:

The purpose of this renewal is to extend the current documented terms and conditions of the computer matching agreement for an additional 12-month period for the USAC, FCC, and ED to exchange information, using the National Lifeline Eligibility Verifier (National

Verifier), concerning applicants to and subscribers of the Federal Affordable Connectivity Program (ACP). Such exchanges are for the sole purpose of benefit eligibility determinations. Specifically, USAC may use the ED data, which identifies individuals with current Federal Pell Grant disbursements in an active award year, to verify that certain applicants to and subscribers in the ACP are eligible to receive the ACP benefits based on receipt of a Pell Grant.

- 1. In paragraph 1 of Section IV of the CMA, DESCRIPTION OF THE DATA TO BE EXCHANGED, the system of records notice publication date and *Federal Register* citation for the "Common Origination and Disbursement (COD) System" is updated to "June 28, 2023 (88 FR 41942).")
- 2. In paragraph 2 of Section IX of the CMA, INCIDENT REPORTING AND NOTIFICATION RESPONSIBILITIES, the ED contact for computer security issues is modified to read as follows:

3. Section XV of the CMA, EXPENSES OF EACH PARTY, is revised to read as follows:

This Agreement does not obligate funds for any particular expenditure, nor does it authorize the transfer of funds and/or resources. It is understood and acknowledged that the Parties intend that an interagency agreement (IAA) between the FCC and ED shall be used to document the reimbursement obligations associated with ED's provision of goods and/or services in support of the ACP as required by the Recording statute, 31 U.S.C. § 1501. Any IAA used to document reimbursement obligations shall be executed by both the FCC and ED before the period of performance commences and shall include the signature of officials with authority to obligate funds and shall be contingent upon the availability of appropriated funds in compliance with the Anti-Deficiency Act, 31 U.S.C. § 1341.

This Agreement does not authorize ED to incur obligations through the performance of services described herein; performance of such services is authorized only by the execution of the Interagency Agreement (IAA) General Terms & Conditions (FS Form 7600A) and Order (FS Form 7600B) in the G-Invoicing system to obligate and transfer funds between the agencies.

The parties acknowledge that an IAA documenting the reimbursement obligations associated with ED's provision of matching services went into effect on February 1, 2023, and will expire on July 31, 2025 (GT&C A2301-027-091-037299). ED and FCC intend to revise the GT&C A2301-027-091-037299 to expire November 17, 2025, so that it will expire at the end of the full CMA renewal period. ED and FCC have an existing order covering the time period from February 1, 2023, through February 29, 2024. ED and FCC intend to establish an order under GT&C A2301-027-091-037299 to cover the time period from March 1, 2024, through November 17, 2024. Moreover, ED and FCC intend to execute two new orders under GT&C A2301-027-091-037299 to cover the CMA renewal period. The first new order will cover the time period from November 18, 2024, through January 31, 2025, and the second new order will cover the time period from February 1, 2025, through November 17, 2025, once ED determines the new operations and maintenance costs. The parties acknowledge that future enrollments and corresponding matching of records by ED would require an additional appropriation from Congress to fund the ACP beyond the existing IAA effective on February 1, 2023. The FCC will notify ED's point of contact in Section XVIII, Points of Contact, within one week if the FCC funding for the connection is exhausted or terminated and the FCC is unable to pay for the connection. If the FCC receives additional appropriations for the ACP after the date of this Renewal, the FCC will notify ED's point of contact in Section XVIII, Points of Contact, as soon as possible but no later than one week before resuming the matching with ED.
