DBC Amends Open Video System and Affiliate ETC Certifications TO Update the Statement of Ownership, disclose all affiliate companies, and other (FCC affiliates) affiliate ownership media assets of 5% or greater, including Digital Broadcasting OVS, LLC., DBC of Puerto Rico, Including the following assets., DBC OVS of California, Inc., DBC San Francisco, California, DBC the 5 Counties of Southern California, DBC Puerto Rico OVS.

This multi filing includes the ETC Exempt Telecommunications Companies., the ETC Certifications consolidated under the DBC Digital Broadcasting Corporation Holding Company. There is a Statement of Affiliates, none of which has cable investments.

DBC is updating its Advanced Telecommunications- Open Video System Services to include the 25 Secretary of States Franchise Authorities, the 210 major DMAs in the USA, and the US territories of Guam, Samoa, US Virgin Island, and Puerto Rico, (the "DBC Subsidiaries"). All additional Roy Jimenez Trust assets are also listed below.

DBC has amended their Open Video System ETC Certifications to update the Statements of Ownership in order that reflects the corporate restructuring. The DBC subsidiaries are be merged into Digital Broadcasting Corporation. Assets will be listed as OVS, and or the ETC assets of the DBC Corporation.
