# Upfront Payments Deadline

All upfront payments must be received at Mellon Bank by 6:00 p.m. ET on August 12, 2005.

- ↓ All payments must be in U.S. Dollars.
- ↓ All payments must be made by Wire Transfer.

# Upfront Payments (Continued)

- ↓ Upfront payments for Auction #81 go to a lockbox number different from the lockboxes used in previous FCC Auctions, and different from the lockbox number to be used for post-auction payments.
- ↓ Failure to deliver the upfront payment by the August 12, 2005 deadline will result in dismissal of the application and disqualification from participation in the auction.

- Please make sure that you always use the same Applicant FRN that was used when you completed your Form 175.



- Please pay special attention to Page 31 of your Procedures PN (Post-Auction Procedures Section) At the close of the auction a public notice is released; successful bidders will have 10 business days after the release of the closing PN to meet their 1st down payment requirement of 20% of their Net Winning Bid.
- Final Payments will be due within ten (10) business days after the date of the release of the public notice announcing that the Commission is prepared to grant a winning bidder's long-form application.
